OPT IN: USING IMAGES OF CHILDREN

We like to have a record of our pupils taking part in the many activities that are offered at the School. We may take photographs of the pupils. We may use these images in our School prospectus or in other printed publications that we produce, as well as on our website, social media, display screens or on project display boards at the School. We may also make video recordings for School conferences, monitoring or other educational use.
